## **Planning Information**

The Planning Sub-Committee of MMRA meets monthly to review and take action on relevant planning matters that will affect residents.

The planning status of current sites that may have significant impact in Mount Merrion is summerised below.

It should be noted that a typical Planning Permission lapses after a period of five years from the date of Final Grant unless the approved development is substantially completed at that time.

#### 1. 88 Trees Road:

- 4 Two storey Dwellings
- 1 Two storey Apartment Block containing 3 Apartments

**Status:** Construction well progressed on site.

- **2a. Union Café:** (same owner as 2b.) Planning Permission granted for 50 apartments by An Bord Pleanála.
- **2b. Flanagans site:** (same owner as 2a.) Planning Permission granted by DLRCC for 48 apartments.

Status: Major site evacuation is almost complete and new basement works progressing. Large trucks removing soil have caused major concern to residents along Deerpark Road, Wilson Road, Callery Road, North Avenue, Greenfield Road and the Rise, most of which are not included in the Contractor's Construction Management Plan.

The Contractor offered some mitigation responses when approached by MMRA, but response still awaited from DLRCC.

### 3. Cherry Garth (Oatlands):

Granted Planning Permission for 63 houses/apartments by An Bord Pleanála.

**Status:** No evidence of any development on site.

#### 4. Thornhill House:

Planning Permission granted by An Bord Pleanála for 42 houses/ apartments.

Further Planning Application sought on 08/10/2019 for an additional 6 apartments, i.e. total 48 units granted by DLRCC despite observations by MMRA and residents. Now on appeal to An Bord Pleanála – decision expected soon.

Further Planning Application sought on 28/02/2020 for an additional 6 houses i.e. total 54 units. Latest date for lodgement of observations to DLRCC is 02/04/2020.

**Status:** Developer plans to commence site works on approved project in April 2020

#### 5. 93 The Rise:

Planning Permission granted by DLRCC for 10 houses.

**Status:** Construction near completion on site. No evidence on restoration of 11 highly treasured mature Yew trees.

#### 6. Glenville, Fosters Avenue

Proposal to build 123 apartments, lodged directly An Bord Pleanála. **Status:** Many observations of concern, supported by professional advice, were lodged by MMRA and by local residents. The application was refused by An Bord Pleanála. To date there is no current live application.

#### 7. 23 Greenfield Road

Planning permission was sought for a single storey dwelling in the rear of existing garden.

#### 7. 23 Greenfield Road (cont'd)

Observations of concern were lodged by MMRA and local residents.

**Status:** The application was refused by DLRCC and An Bord Pleanála.

### DLRCC Development Plan 2022 – 2028

MMRA attended the Pre-draft Consultation and made their Pre-draft Submission to DLRCC before the due date of 28/02/2020. The overall time frame of 104 weeks from 03/01/2020 for completion of 2022 – 2028 Development Plan is set out on the DLRCC ON-LINE "HAVE YOUR SAY" document.
